

**[CONSTITUTION**

**Assignment of Functions (Minister of Finance and Economic  
Development) Notice, 2018**

---

IT is hereby notified, that his Excellency the President has, in terms of section 104(1) of the Constitution as read with section 37(2) of the Interpretation Act [*Chapter 1:01*], assigned to the Minister of Finance and Economic Development—

- (a) the administration of the Acts set out in the Schedule; and
- (b) the functions conferred or imposed on the Minister of Finance and Economic Development save to the extent that those functions have not been assigned to some other Minister.

Assignment of Functions (Minister of Finance and Economic Development) Notice, 2018, Statutory Instrument 100 of 2018, is hereby repealed.
